## MAT CLEANER

SURFACE PROTECTING AND EXTREMELY ECONOMICAL CLEANER FOR THE REGULAR CLEANING OF MARTIAL ARTS MATS

### Description

The ZEBRA MAT CLEANER is a highly concentrated, pH-neutral cleaner for martial arts mats.

### Application

- (1) Preparation** Remove all coarse dust and dirt from the surface using a vacuum cleaner or sweep it clean using a soft broom.
- (2) Mixing Shake** ZEBRA MAT CLEANER well and mix a solution by adding it to water in the concentrations provided in the table, depending on the degree of contamination.
- (3) Manual routine cleaning** Clean the surface using a standard mop with a microfiber cover and the classical mopping technique without exerting too much pressure. To prevent the mats swelling, do not use excessive amounts of cleaning solution. Do not walk on the surface and make sure it is well aired while it is drying.
